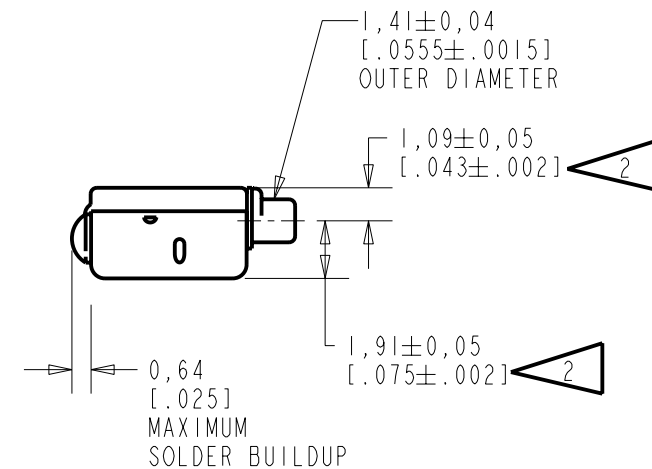
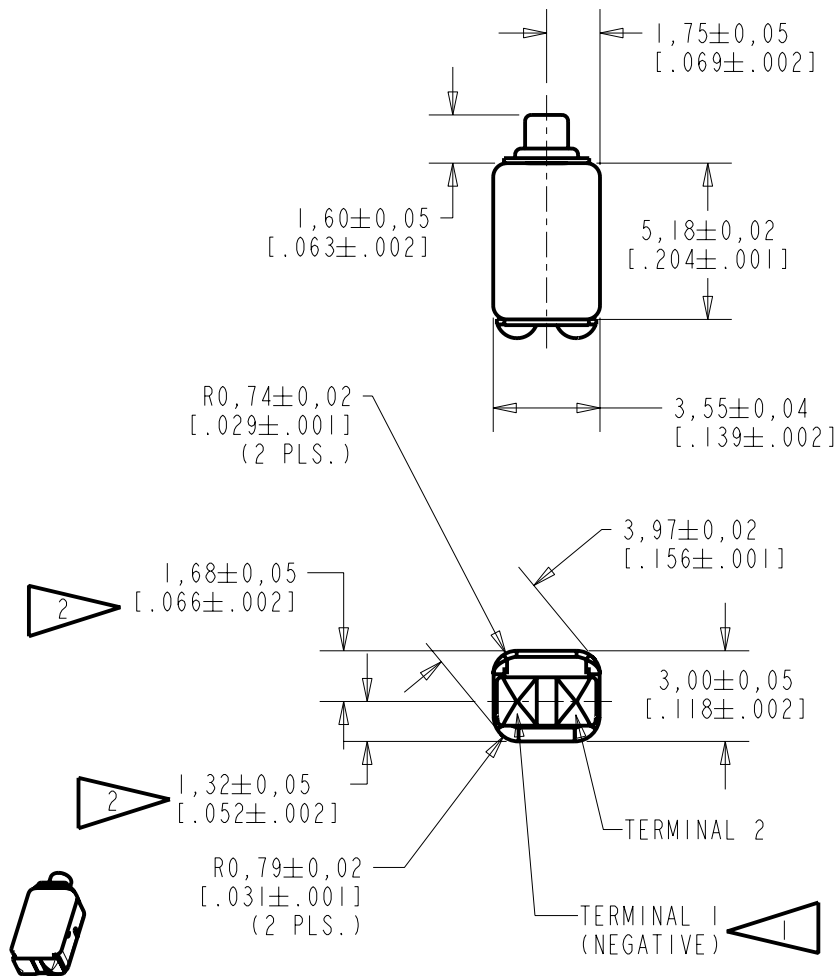


NOTES:

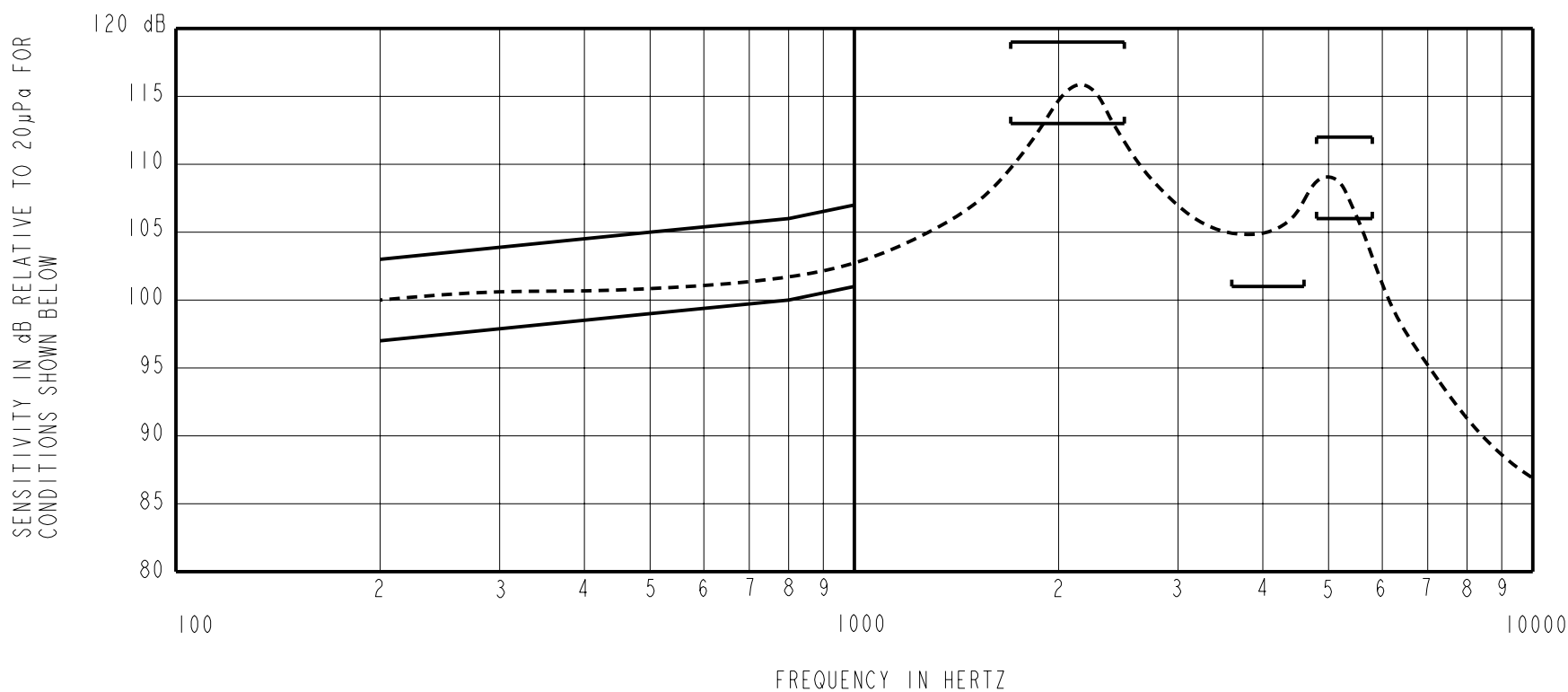
